9. Business Items

a. YAC Social – City Staff

Background: Each year, local YAC's (or commissions like) participate in a social event, to which commissions from other cities come together and discuss information regarding youth needs/concerns/opportunities.

Recommendation: YAC Members register and participate in the YAC Social taking place on Friday, April 9th at 4 P.M. City Liaison to follow meeting with the registration and zoom information for the event to YAC members.

b. Work Plan Events 2020-21

1. Film Competition

Background: The Youth Advisory Commission is looking to partner with both Milpitas High School teachers and the Arts Commission to provide and plan a film competition to which Milpitas Teens will be able to submit their films. MHS Staff and Arts Commission, will be asked to help judge the films and provide feedback to the students participating. The event is scheduled for May 15th.

Recommendation: Commissioners to provide final flyer concept, details of the confirmed category outline, and panelist confirmations. Commissioners to also discuss final details of event.

2. Mental Health Awareness

Background: The Youth Advisory Commission has added the hosting of a Mental Health Awareness event, in hopes of partnering with National Alliance on Mental Illness (NAMI).

Recommendation: Commissioners to confirm the final details they discussed and provide action plan for sharing information. This event is to be hosted on April 21, 2021 virtually through zoom. City liaison will share the information through the MUSD community.

3. Teen Center Events

Background: Each year, the Youth Advisory Commission partners with the Milpitas Teen Center to host, assist in planning, and promoting events for the Milpitas Teens. This year, due to the pandemic, the Youth Advisory Commission has decided to provide Milpitas Teens with care packages to be picked up by students. This event will take place on the week of May 24.

Recommendation: Commission to confirm the day or days that they will provide Teens with finals giveaway packet. Commission to finalize the items needed for purchase along with providing further details/ideas for the packet that contains positivity notes and other resources.

4. Tobacco Free Communities

Background: The City of Milpitas submitted a grant proposal for the County of Santa Clara Public Health Department (SCCPDH) Healthy Cities Project- Tobacco Free Communities Program. On February 13, 2020, staff received notification of the funding for the grant. The overall goals are to educate youth, parents and the community to prevent youth use of flavored tobacco and vaping products in the City of Milpitas and reduce tobacco retailers in Milpitas, grandfathering current retailers. Specific objectives include informing the public of any policy changes around tobacco sales and educating youth on methods used to advertise flavored tobacco products and e-cigarette and vaping devices, educate parents and “trusted adults” to recognize signs of youth tobacco use and effectively communicate with youth about the dangers.

The City of Milpitas will be entering into contract with the County of Santa Clara on the terms of the grant and will act as the grant administrator for the term of the agreement.

Recommendation: Sub committee to provide details of researched items from last months meeting, which was to contain: Training videos, print and online campaigns ideas, and townhall meetings.
