VI-1) ZONING TEXT AMENDMENT – PROHIBITION ON COMMERCIAL CANNABIS ACTIVITIES AND PERSONAL USE CANNABIS CULTIVATION REGULATIONS – CITYWIDE – P-ZA18-0004: Consider and adopt a resolution recommending that the City Council adopt a City-initiated Zoning Ordinance Text Amendment to prohibit commercial cannabis activities within the City of Milpitas and to regulate the cultivation of cannabis for personal use. The regulations are proposed to be adopted as both an urgency ordinance and a regular (non-urgency) ordinance. The proposed regulations would prohibit all medical and adult-use commercial cannabis activities, including but not limited to, commercial cultivation, delivery, distribution, manufacturing, microbusinesses, retail/dispensaries and testing laboratories. The proposed ordinance would also regulate indoor cultivation of cannabis for personal use and prohibit outdoor cultivation of cannabis as permitted by State Law. The proposed action is exempt from environmental review pursuant to Sections 15060(c)(3) and 15061(b)(3) of the State CEQA Guidelines.
