VIII. PUBLIC HEARING

- VIII-1 BAPS MANDIR FAÇADE REMODEL AND CANOPY ADDITION – 1430 CALIFORNIA CIRCLE – P-UA19-0002, P-MS19-0010:** A request for a Conditional Use Permit Amendment to allow for an increase in building height above 35 feet within the Industrial Park zoning district, and a Minor Site Development Permit to remodel an existing building façade.
