 - a. **Advisory Area Discussion**

Background: As part of the Commission's Work Plan, the Commission is to discuss and provide high-level feedback and suggestions regarding youth and teen concerns, areas that need improvement or need to be focused on, and advise City Council on pertinent youth and teen topics. In the past meetings, youth vaping and youth homelessness was discussed.

Recommendation: Continue discussing any topics, challenges, and concerns that Commissioners have observed pertaining to youth and teens in our community.

b. Volunteering and Tabling

Background: As part of the Commission's Work Plan, the Commission will volunteer at City events and Milpitas Teen Center events. The Commission will also table at different City events to educate, celebrate, and bring awareness to the cultural significance of the event. A sign-up sheet was sent to all Commissioners to sign up for events and tabling. The next tabling event will be held at the City's Lunar New Year event on Saturday, January 25, 2025 from 6-8:30 p.m. Chair Huang and Commissioner Chen are assigned to table the event.

c. College Workshop

Background: As part of the Commission's Work Plan, the Commission will host a College Workshop in partnership with a community-based organization. The goal of the workshop is to prepare high school students to successfully enter college. The workshop was rescheduled to early 2025. The Commission is considering partnering with San Jose City Community College to host the workshop.

Recommendation: Receive updates from College Workshop subcommittee.

d. Youth Spelling Bee Competition

Background: As part of the Commission's Work Plan, the Commission will host the annual Youth Spelling Bee Competition in March 2025. A total of 30 1st-3rd graders and 20 4th-6th graders competed last year. The Commission would like to continue improving on the competition for families and competitors.

Recommendation: Receive updates from Youth Spelling Bee Competition subcommittee.

Background: As part of the Commission's Work Plan, the Commission will host a Volleyball Competition. The Competition will replace last year's 3 vs 3 Basketball Competition.
