a. Trails, Pedestrian, and Bicycle Master Plan

The Trails, Pedestrian, and Bicycle Master Plan is in the approved City 2020-2025 Capital Improvement Program. This project provides an update to the existing 1997 Trails Master Plan and the 2009 Bicycle Master Plan document. The plan will focus on updating existing trails, bicycle, and pedestrian routes and make recommendations for facilities improvements, programs, and policies.

b. CDBG Process

The City of Milpitas is designated as an Entitlement Community by the U.S. Department of Housing and Urban Development (HUD), and is allocated grant funds on an annual basis to meet the needs of low-to-moderate income individuals through the Community Development Block Grant (CDBG).
