- b. **Business Single Use Plastic Project and Survey:** The Commission identified an effort to encourage businesses to switch to non-plastic foodware as part of its work plan with the objective to: Provide information to businesses on plastic alternatives. Commission should continue to discuss scope of this project, identify target businesses (types), and identify action items/areas for responsibility for research for a potential resource list, and brainstorm ways to promote the resource. Survey was sent to large Milpitas businesses with on-site cafeterias in early August. Discuss response level and possible next steps.
